Commonly asked Questions and Answers:

Q. Why does the Corporation exist?

A. To create and maintain a school for Christian instruction in accordance with Article II of the WSCS Constitution so that those taught may worthily occupy their places in the home, church and society.

Q. Why should I become a Corporate Member?

A. Corporation Membership gives you voting privileges regarding important decisions concerning West Sayville Christian School. Attending Corporation Meetings also gives you a chance to voice your ideas and concerns during discussion of important issues.

Q. What things do Corporate Members vote and act upon?

- A. At annual and special Corporation meetings, Corporate Members are able to:
- Vote for Nominees to be elected to the Board of Directors
 - Present Nominations from the floor
 - Vote to approve the school's proposed operating Budget
 - Hear the annual committee reports from the Board of Directors
 - Vote to approve important recommendations from the Board of Directors

Q. Why is it so important to vote on Board Members to be elected?

A. The Board of Directors is the legally accountable body within the corporation with responsibility for the overall operation of the school (as described in the WSCS Constitution, pages 3-5). It is composed of nine members who serve as trustees of the corporation. It is important that concerned members vote for the nominees they consider most capable to serve in this capacity.

Q. How do I know if I am a Corporate Member and what if I'm not?

A. Check the list below! If your name does not appear, simply call the school office @ 631-589-2180. You are eligible to be a member if you are eighteen years of age or older, regularly attend an evangelical church and are in agreement with Articles II and III of our Constitution (Constitution Pg. 2).
